

## **Stud Service Contract**

### **STUD FEE**

☐ Paid as a deposit (if Bitch is left with stud), with balance to be paid upon litter whelping

☐ Pick of the litter (Male/Female puppy), determined by the Stud Dog Owner

The fee for this service is **\$700**. The Bitch Owner will pay the Stud Owner a nonrefundable fee of **\$50** if the Bitch is left at the Stud Owners home to breed. This \$50 will be subtracted from the service fee at the whelping of the litter. Litter registration papers will NOT be signed unless Stud Fee and any associated veterinary or other agreed upon expenses are paid in full.

### **PICK OF THE LITTER**

Stud Dog Owner reserves the right to take a puppy in lieu of a stud fee, unless stud fee is paid in full up front prior to breeding. Stud Dog Owner will choose said puppy at 7 weeks of age, before any puppies from the litter have left the Bitch Owner's residence.

### **DEFINITION OF “LITTER”**

A litter, for the purposes of this contract, is defined as a minimum of **3 puppies born** alive. If breeding does not take, a repeat breeding will be given to the same Bitch on her next season. If the Bitch fails to conceive on the return service, this contract is terminated.

### **STUD DOG OWNER AGREES TO:**

1. Provide five-generation pedigree of the Stud dog
2. Provide documentation of a current clear Brucellosis screening
3. Take proper care of the Bitch while in the Stud Dog Owner's charge
4. Sign litter registration promptly upon payment in full of Stud Fee and any other outstanding balance related to breeding

### **BITCH OWNER AGREES TO:**

1. Pay the agreed Stud Service fee before the bitch is serviced
2. Pay the balance of the Stud Fee upon birth of the litter
3. Provide a five-generation pedigree of the Bitch to be bred
4. Provide documentation of a current clear Brucellosis screening
5. Provide documentation of a clear vaginal culture. If the vaginal culture is not clear, or the female required antibiotics, the Stud owner has the right to refuse breeding in order to protect the Stud.
6. Provide documentation of DNA testing (MDR-1 and PRCD).
7. Once this blood work and culturing is performed, the Bitch Owner agrees to keep the Bitch away from other dogs and dog parks until after the breeding.
8. If there is any suspicion of a problem, the Bitch Owner shall be liable for any loss of a Stud Dog's future services due to the Bitch Owner's concealment of health problems.
9. Send the Bitch in good health, free of parasites or infections, and in season.
10. The Bitch should have a collar with tags, including name and information.
11. Notify the Stud Dog Owner in writing, no later than 70 days after breeding, if no pregnancy results from the mating. Failure to do so will result in no return service being provided.
12. Keep the Bitch properly confined following breeding to ensure no other dog could mate with her accidentally before her season is complete.
13. Pay any and all veterinary and financial arrangements, including, but not limited to traveling expenses, emergency vet care related to this breeding, etc.

### **OTHER AGREEMENTS:**

Bitch will be bred two to three times naturally depending on the Bitch's acceptance. We will make every effort to cover the entire breeding cycle of the Bitch; however, it is up to the Bitch's owner to determine her heat cycle.

Stud Dog Owner would appreciate being informed of puppies that are returned for any reason. An effort will be made on the Stud Dog Owner's part to help the Bitch owner find a new home for said puppy.
